RELEASE OF LIABILITY, WAIVER OF CLAIMS,
ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

In consideration of being allowed to operate a golf cart within the confines of the Lac Pelletier Regional Park on any designated roadways and trails therein, and for other good and valuable consideration, the receipt ad sufficiency of which is hereby acknowledged by all parties hereto, I herby release Lac Pelletier Regional Park Authority, its Officers, Directors, Employees, Servants, Agents and other appointees or representatives from all responsibility for bodily injury, property damage, liability, costs and expenses of every nature and kind howsoever arising, weather as a result of accident or negligence, from or in consequence of the operation of my golf cart within the confines of the Park as aforesaid.

I further release, remise, discharge and agree to save harmless the Lac Pelletier Regional Park Authority, as wall as all of its respective Officers, Directors, Employees, Servants, Agents and any other appointees or representatives from all claims and rights of action which may arise as a result of the operation of my golf cart,

I am fully aware that there is a risk of personal injury to myself and others in the use of my golf cart and I fully accept the risk of potential harm to myself or others and also the risk of damage to property which may be suffered by myself or others. I accept all legal and physical risks related to the operation of my golf cart and waive and relinquish any right I may have to sue for damages, from any cause including negligence on the part of the Lac Pelletier Regional Park Authority, as well as any of its respective Officers, Directors Employees, Servants, Agents and any other appointees or representatives. I further agree to indemnify, save and hold harmless the Lac Pelletier Regional Park Authority, and its respective Officers, Directors, Employees, Servants, Agents and any other appointees or representatives from and against any and all claims of loss, injuries, or damage sustained by any person including myself, or damage to property, and all expenses including solicitor/client legal costs, incurred or arising from the use of my golf cart as herein before provided,

The terms hereof shall be binding upon me, my heirs, executors, administrators and assigns (including others to whom I may lend my golf cart) as well as any Corporation and its Officers, Directors, Shareholders, Successors and Assigns on whose behalf I execute this RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

ANNUAL GOLF CART REGISTRATION APPLICATION

A GOLF CART REGISTRATION AUTHORIZES THE OPERATION OF A GOLF CART ON ROADWAYS AND TRAILS PROPERLY DESIGNATED BY LAC PELLETIER REGIONAL PARK AUTHORITY AS PERMISSABLE FOR THE OPERATION OF GOLF CARTS. IT IS THE RESPONSIBILITY OF THE GOLF CART OWNER TO KNOW WHAT ROADWAYS AND TRAILS ARE PERMISSIBLE FOR THE OPERATION OF GOLF CARTS.

The owner of the golf cart must have appropriate third-party liability insurance for the golf cart and state same to the Lac Pelletier Regional Park Authority. Liability insurance must be continuously maintained in the name of the owner of the golf cart, for the entire time the golf cart is registered/or should be registered with Lac Pelletier Regional Park Authority.

It is the responsibility of the owner of the golf cart to maintain it in safe and proper working order.

The fee for golf cart registration of \$25.00 annually (this fee may be adjusted annually). The registration expires on December 31.

The registration number sign provided to the owner of the golf cart shall be affixed to the left side of the golf cart in a manner as to be visible at all times.

The applicant agrees that the golf cart shall **NOT** under any circumstance be used by any person:

1. Under the age of 16 years of age;
2. Under the influence of intoxicants, narcotics or other substance abuse;
3. In any race or contest;
4. In any willing and wanton abusive, reckless or unlawful manner;
5. With more than the approved number of riders (one person per seat);
6. Without a non-restrictive driver's license.
